INFORMATION & REGULATIONS

- Please see the registration form for specific camp locations and age groups served.
- Camps will be closed Monday June 24th and on Thursday, July 4th.
- Registration forms will be accepted on a first come, first served basis. A \$10 deposit (per child) is due at the time of registration to hold your space(s).
- You will be contacted during the week of June 22nd by your camp director with camp details.

Eligibility

UrbanPromise camps are intended for children who live in the neighborhoods immediately surrounding our camp locations (see registration form). *Any exceptions to this rule are at the discretion of the camp director.*

Field Trips

Each camp goes on weekly field trips, normally on Fridays. Children must wear their camp t-shirts (\$10) on field trips. The \$10 deposit paid with registration will be applied to the cost of the shirt. Shirts from previous summers may be worn; in that case, the deposit money will be refunded to you at the start of camp or applied to the field trip fee. T-shirts will be dispersed based on availability.

The field trip fee for this summer is \$40 per child. This flat rate covers all 5 field trips. If you would like your child(ren) to participate in the field trips, the fee must be received by the first day of camp, **June 25, 2024**.

UrbanPromise Camp Regulations (agreed to in previous form)

- I have read the Information and Regulations sheet and agree to uphold and support the standards, rules and guidelines as outlined by UrbanPromise.
- I understand that my child will need to attend a minimum of 3 days a week to stay registered in the program. If they need to be absent for a particular reason, I will communicate that reason to the Director in person or in writing.
- I give permission for my child to participate in the activities sponsored by UrbanPromise and other cooperating organizations in the neighborhood.
- In case of a medical emergency, I understand that an effort will be made to reach me. However, I do give permission for the staff of this program to authorize emergency medical care for my child.

- I understand that UrbanPromise and the cooperating organizations are only responsible for my child during programming hours.
